COVID-19 Vaccines: Are they Safe, Effective, and Free?

Government officials who lie and mislead the public must be impeached and removed from their posts. The directors of the NIAID¹ and the CDC² repeatedly make the following statement: "COVID-19 vaccines are safe, effective, and free." However, every single assertion in their statement is false and misleading.

COVID-19 Vaccines are Not Safe, Effective, or Free

(1) **Are COVID-19 Vaccines Safe?** A vaccine that causes blood clots, strokes, heart attacks, myocarditis, pericarditis, nerve damage, Bell's palsy, Guillain-Barré, and death is not safe.^{3, 4, 5, 6, 7}

(2) **Are COVID-19 Vaccines Effective?** All unbiased and reliable data indicate that vaccinated and unvaccinated individuals have an equal rate of positive SARS-CoV-2 RT-PCR tests and the same COVID-19 Disease hospitalization and death rate. Dr. Richard Fleming, M.D., Ph.D., J.D., has extensively analyzed Pfizer's own data and concluded COVID-19 vaccines' *absolute* efficacy (real-world risk reduction) is 1%. A 1% risk reduction is statistically insignificant. Therefore, the chance of reducing COVID-19 disease by receiving any of these vaccines is zero.^{8, 9, 10, 11, 12, 13, 14, 15, 16}

COVID-19 Disease is not caused by a virus; therefore, a therapy (vaccine) that attempts to target a virus (the wrong cause) will not affect the occurrence of the COVID-19 Disease.^{17, 18}

(3) **Are COVID-19 Vaccines Free?** Taxpayer money has paid for all aspects of the vaccines, from research and development to manufacturing and marketing. Therefore, the citizens have already paid for and continue to pay for these vaccines. Our tax money brings in massive financial profits for the vaccine manufacturers. The Government collects taxes from its citizens and siphons the tax money to vaccine manufacturers and top pharma executives through multibillion-dollar vaccine-purchase contracts.^{19, 20, 21}

What is the efficacy or risk reduction of these vaccines? To answer the question, we must distinguish between "relative" efficacy versus "absolute" efficacy. Relative risk reduction is obtained in artificial settings and clinical trials. Absolute risk reduction is the effect of a drug or vaccine in the real world. With time, real-world Covid vaccine data (absolute risk reduction) is revealed, and the gap between clinical trial and real-world results narrows. The discrepancy between the two data (expected vs. obtained) is then attributed to a supposed delta variant. But the truth is that the vaccines were always 1% (0%) effective at reducing symptoms.

On 8/30/2021, Duke University sent the following message to all University students, faculty and staff, "[i]n the last week alone, 304 undergraduates, 45 graduate students and 15 employees tested positive for COVID-19. *All but eight of these individuals were vaccinated*, and the vast majority of them were, and continue to be, asymptomatic."
